### EXHIBIT RULES AND REGULATIONS

**Contract for Space** — The Application for space constitutes a contract for the right to use the space allotted. In the event of fire, strikes, acts of God, war or other uncontrollable circumstances, this contract will not be binding. Exhibit space will be assigned on a first-come, first served basis.

**Use of Space** — All demonstrations, interviews, or other sales activities must be confined to the limits of the exhibit. No exhibitor shall assign, sublet, or share the whole or any part of the space allotted without the knowledge and consent of the DNA Administrator. Aisles must be kept clear.

**Liability** — DNA, any officers or staff members of the same, will not be responsible for the safety or the property of the exhibitors, their agents or employees, from theft, damage by fire, accident or other cause, but will use reasonable care to protect the exhibitor from loss.

**Insurance** — Exhibitors wishing to insure their goods must do so at their own expense.

**Care of Building and Equipment** — Exhibitors, or their agents, shall not injure or damage the walls or floors of the building, or the tables. No signs or any other articles shall be posted, nailed, or otherwise attached to the floors, walls, furniture, or fixtures. When damage appears, the exhibitor is liable to Delta Nu Alpha and the Radisson Bay Harbor Hotel.

**Hotel Accommodations** — Applications for hotel reservations should be made by exhibitors directly with the Radisson Bay Harbor Hotel. You may contact the hotel directly at 813-281-8900. The rate is \$79 single to quad occupancy. In order to receive the special group rate, be sure to identify yourself with Delta Nu Alpha Transportation when making your reservations by September 1, 2004.

**Exhibit Fee** — The fee is \$200 for Registration Exhibits including two name badges; \$260 for Fun Nite at the Aquarium Exhibits including one name badge. Additional Registration Exhibit badges are available for \$25 and Fun Nite tickets and name badges are available for \$60. The fee is due when the contract for exhibit space is submitted. Contract and fee due not later than August 30, 2004. Note: Exhibitors badges provide entry to the Registration area or the Fun Nite only. Entry to any other events require the purchase of Full Conference Registration or individual event tickets.
